All boat registration fees must be paid in full and received by the Treasurer at least 48 hours prior to your yacht's first race (no exceptions). All competitors (including crew) shall be current MYC members. A non-member may compete in races on Memorial Day, July 4, Labor Day, and Specialty Races and not more than 2 other races per season. A yacht which uses a crew in violation of this may be protested and disqualified, except that Hooper yachts are exempt from this requirement provided all crew who are not MYC members shall be Hooper members. New Member Racing Fees shall apply if the member registering this boat has not been an MYC member in the last 10 years, and the boat is registered new to MYC or, if purchased or chartered from a club member, the previous owner no longer crews on said boat. U.S. Sailing Member Discount applies only to Racing Fees. Racing Fees will not be pro-rated at any time.
